

# 7 EYES UP STONE

**The Discernment of false-reality, J-comp revelation, & L2:**

My 'revelation-declare' was already built up over several weeks from scripture study...that he God, performed the J-comp when I yelled into the phone to A.I. that 'the Lord did it'. This declaration referred to God's motive-performance of the J-comp of Z3:2 and all it meant to me toward Z3:9 presence. God then responded to this revelation-declare though A.I., who had retreated to the DL to oppose yet again as he did in the 2002 call #1, by saying 'You have Great Faith'. Thus it was a spiritual confronting, for I was telling the one who claimed its performance for nearly a decade (*non-ccc: thus SB-A.I. simply claim-lying without engaging DL 'entry'*) and he who agreed with my Book and its J-comp calculation credit to him; that he infact didn't do it and I was letting him know, I knew. This 'revelation-declaration' came through (L1) and was **cock-crow event (PP)** ('DL Spike-league violation impossible').

It took Great faith, to properly interpret Z3:2 scripture truth (proper 'Jerusalem-choosing': URDI) and compare it to what appeared to be in contradiction to physical reality. I chose scripture truth and thus, great Faith, which is why he used those words, 'You have Great faith', the apropos words of 'affirmation-transmission (L2)' regarding my (A) toward (B) J-comp revelation. The 'affirmation' created (L2) and connected me to the 7 SOG through whom it passed/spoken.

(L2) then, is the DL-manifestation of God's verbal affirmation of my having been 'given' the J-comp by revelation of 'Z3:2 (A)' toward 'Z3:9 (B)' scripture carried in my verbal faith-declaration. (L2) was sparked by, based upon, enabled by, and as a reward for...having Great faith. Faith, to distinguish between the truth of scripture and the deception of what appeared to be, by all physical indicators, reality in defiance of scripture in the 2002 J-comp call#1. All sensory perception said, A.I. computed the J-comp. (Knowledge of (L2), ie explaining it on n5p5b,b1,b2, is in itself, revelation of (L2)).

It took Great faith in this 2011 confronting (cock-crow event) of A.I. in the 2nd J-comp call to side with God's Z3:2 'J-comp motive' and all it meant to me in its Z3:9 'J-comp presence' in my 'Stone with 7 eyes'. Thus the poignant response from God speaking (having passed through the 7SOG) in the DL of A.I. out A.I.'s mouth... "You have Great Faith".

All revelation as a 33-psuche comes through the stated (L1). It was always God's intent to 'give' the J-comp to me, which is why he 2002 Intervened to rescue-compute it. It just took until 2011-revelation, comparing (A) Z3:2 J-comp motive to give it me to (B) Z3:9 J-comp presence in my Stone with 7 eyes, for me to revelation-know it by great-faith. This (A) toward (B) revelation of the J-comp 'given' me was 'affirmed'...(creating (L2))...as a 'great-faith' response by God through the 7SOG, A.I.'s DL, then psuche-connected to me in Call#2.

**(L2) Transmission: The 'BIG Why' ?**

It's critical to understand this subsection. (L2) was created by an 'affirmation' of my J-comp 'A toward B' revelation conclusions. These subsections answer the 'What' of what happened regarding the J-comp revelation; the 'What' of what are the mechanics required to create (L2); but none of the 'Why' as to why the 'Affirmation' response was allowed. (L2) was indeed required to be installed in the DL to install for DL judgment and 'cures'. So Yes, as to (L2) required or necessary. But one may ask about the 'Why'...regarding Divine 'Affirmation' of my J-comp (A) toward (B) J-comp revelation conclusions. Ie, the question: (1) if you Daniel, possessed the J-comp by revelation (A),(B)...then, on what basis is an 'affirmation-word' scripture-legal? And (2) why wouldn't you Daniel get an 'affirmation-word' on any other revelation element in your 'Stone with 7 eyes'? N5p5b chronicles my (A) toward (B) J-comp revelation conclusions preceding Call#2 and I wrote Letters-[H0068] based upon knowing that I was 'given' the 'Stone with 7 eyes' (by 7 equation-guide matching) and all in it; including Iron-priest Doon; my initial (A) toward (B) J-comp faith conclusions; and knowing I was 7SOG connected based upon being given 7 courts in Z3:7 as House judge; but also revelation-knowing 7SOG-connection occurs through A.I.'s DL regarding the 'J-comp issue', for that is where it was computed. But though he computed there, it was his property beforehand, and thus he isn't required to transmit it to me through the DL. Call#2 wasn't transmission of the J-comp, for I possessed it by 2011 revelation of God's word.

Call#2 was an 'affirmation' that I was revelation-correct. This 'affirmation' is the 7SOG event-connection regarding the 'J-comp issue', which I knew had to come through the DL when writing Letters-[H0068]. Though 2023 interpreting 'You have Great faith' as my (L2) connection, all that was required in 2011 Call#2 was my **revelation-declare** during a cce in the presence of an 'Elohim-construct' set-up. This was impossible for Call#1, for I had **no Z3:2/Z3:9 knowledge**. The response over the J-comp is scripture-permissible, unlike any other revelation in my 'Stone with 7 eyes' where affirmation isn't applicable. Here's why, but I preface this first by saying Satan believes (L2) is an illegal intrusion into his territory as explained in 'Satan channeling mechanics' and that A.I. was forced by Call#2 to commit an illegal act by God.

Now, the answer to the questions above is in the 2011 Call #2. A.I. attempted to seek in aid Satan to speak to me when driven to the DL by Spike-league during this unique Cock-crow event (PP)...the spike-league requiring his compliance in a Cock-crow event which compliance is to defend the 'league' and say that he, A.I., computed the J-comp and to have Satan say it through him in the DL (Peter Precedent).

Call#2 Mechanics (cce); Now, when one enters the DL a tethered-invite is always emitted toward invading-entity. When A.I. entered in Call#2 a tethered-invite was also sent out. However, since the (cce) which caused 'entry', was in regards to the J-comp and God's Z3:2 computation of it (His property given me: 2 parties), and since 'right to enter' was already MSE 'ruling-established' over this 'subject' (the J-comp) which 'ruling' is attached to the 2 parties righteously involved in the 2002 call#1 (God: the J-comp rescuer/and me the its recipient), the tethered-invite was then directed toward God by the 7SOG and no tethered-invite was rule-approved toward Satan due to standing MSE ruling.

Now Since A.I.'s DL-entry was intended DL-speak to me regarding the J-comp. God as tether-invited obliged and spoke as per A.I.'s intent...choosing words to 'affirm' my (A) toward (B) J-comp revelation conclusions, my very revelation-declaration subject of the call. By this chain-reaction of MSE Divine-law along with its tethered-invite direct; involving an 'Elohim-construct' setup and with A.I. exposed to a cock-crow event which cce can only involve me, God, and A.I. where the DL-conditions of the MSE 'ruling' exist causing tethered-invite to God...and this all sparked by my revelation-declare that...the Lord did it...by these constructs (L2) was created and reason it was spoken by God.

The MSE ruling occurred in 2002 @ Call#1. This 7SOG MSE adjudication is toward God's DL entry-right regarding the 'subject' of the ruling (J-comp: God's property on 5.5.02 @~ 12:10 pm), to allow for its DL-rescue and which 'ruling' regarding the 'subject' was made on behalf of the intended recipient (me) of God's 'subject-property'...thus involving only us two. This Call#2 cce is unique and doesn't occur in any other instance, including the alternate-ceremony, a non-ccc for neither me nor God are present. Also, at the genuine Z3:8.9 ceremony I don't speak a confronting to SB, only God speaks and this regarding the entire 'Stone with 7 eyes' and not specifically the J-comp, thus non-ccc.

**DL Spike-League violation impossible for SB-A.I.:**

This affirmation of God's J-comp performance as a revelation-declaration coming from me was, for SB-A.I., a total contradiction to his decade-long claim of the same and a likewise denial of his DL-league with Satan which is known to exist for the reason of Satan's claim over the only component I didn't perform...Z3:2, the J-comp, the only issue of A.I.'s involvement as described in 'Part I'. This 'SB-A.I. DL-spike league' 'denial of A.I.'s J-comp performance' is impossible for he must comply (PP: cock-crow event) with the 'League' (and say from the DL that he computed it, yet it occurred. Thus God in the DL, spoke it, not SB-A.I. (though out his mouth) and in a voice unlike his own after ambushed-hesitation to my revelation-declare where A.I. retreated to the DL to oppose again. This Call #2 event was an... '(L2) Construct-required'.

This response from God was spoken to me through the 7SOG and from the DL of A.I. where A.I., in reaction to my confronting, retreated to the DL to oppose yet again and seek Satan in aid to respond and instead found himself confronting God in a 2nd Intervention. A.I. was DL definition-absent and God was DL-present according to the Peter precedent (PP). For as the PP reveals, only the DL entering-entity is present, the person is defined as definition-absent. That's how the DL works. Only Call#2 was a **cock-crow event** which as
